

Respected Sir,

This is with the reference to above mentioned subject and reference that your school is granted permission to start one division of class-10 Gujarati Medium W.E.F. June-2006. Your School is given permission to start one division of class-10 Gujarati Medium W.E.F. June-2006 in accordance with norms, rules and regulations prescribed in grant in aid code of Gujarat State Secondary Education Board of 1972 and thereafter 1974 and letters and G.R. Issued time to time by G.S.E.B. with following conditions.

1. There should be adequate provision of ventilated classrooms and health-care facilities in school premises.
2. School should appoint required and qualified academic staff. School can get necessary guidance in this matter from District education officer. After appointing qualified teachers, School has to submit registration forms of teachers to concern D.E.O.
3. School must appoint a full time qualified school principal and get the staff profile approved from concern D.E.O.
4. School should ensure science laboratory, equipments for science lab as required in class -10 and other teaching aids and infrastructural facilities.
5. School should have required regarding material for syllabus of class-10 and should enrich school library.
6. School must not compete with other surrounding school for students' strength.
7. School must have sufficient balance in school account (joint) and must pay teachers salary through cheque.
8. In case of "Uttar buniyadi School" school must have enough land hostel facility and workshop place.
9. School should first admit its own students from class-9 to class-10 there after school can admit student from other schools for remaining seats school should not discriminate students on any reason for given admission.
10. School is bound to follow rules and regulation regarding grant by state government and commissioner of higher education.
11. The approval is sanctioned with condition that school has required permission for utilization of building and playground.
12. It student from any other board or university is given admission in the school: school should verify related documents physically from of other board or university. SMC is completely responsible for such admission.
13. School should ensure fire-safety arrangements in premises.
14. With this permission letter" school is not entitled to receive grant automatically. School should apply separately for grant to commissioner of higher education, govt. of Gujarat.
